FOR TWO YEAR OLDS. Non-Lasix Race pursuant to 4043.2 (7)(e)(5) Lasix not permitted within 48 hours of post time. By subscription of \$150 each which should accompany the nomination; \$750 to pass the entry box and an additional \$750 to start. For horses not originally nominated, a supplemental nomination payment of \$1,500 along with the entry and starting fees may be made at any time prior to the closing of entries. The purse to be divided 55% to the owner of the winner, 20% to second, 12% to third, 6% to fourth, 4% to fifth and 3% divided equally amongst the remaining finishers. Weight 122 lbs. Non-winners of a Graded Sweepstake allowed 2 lbs.; of a race other than maiden, claiming, starter or state-bred allowance allowed 4 lbs. A trophy will be presented to the winning owner. Closed Saturday, October 23, 2021 with 20 Nominations.

### Footnotes

ROCKEFELLER coaxed from the gate, showed the way along the inside while in hand under some pressure from SPEAKING to the outside, came under light coaxing at the three-eighths, spun two to three wide into upper stretch, dug in under a drive edging clear through the final furlong kept busy to the finish. COOKE CREEK traded a bump at the start with CAIRAMA, chased four wide under coaxing from the three-eighths, continued four wide into upper stretch and kept on to secure the place honors. JUDGE DAVIS chased just off the inside under coaxing from the five-sixteenths, continued just off the inside into upper stretch and weakened in the late stages. MIDNIGHT WORKER four then three wide in pursuit, got coaxed along at the three-eighths, spun three wide into upper stretch and weakened. CAIRAMA traded a bump at the start with COOKE CREEK, chased two to three wide under a ride from three furlongs out, angled five wide into upper stretch and weakened. SPEAKING prompted the leader from the outside three then two wide coming under coaxing at the three-eighths, got shaken off with five-sixteenths to go, went three wide into upper stretch in retreat and folded in the stretch being eased home to the finish.
