FOR FILLIES, TWO YEARS OLD WHICH ARE REGISTERED MINNESOTA BREDS. By subscription of \$250 by Monday, April 1. Late nomination fee: \$750 by Saturday, June 1. \$500 to enter, \$500 additional to start. Supplemental nominations of \$5,000 will be accepted at time of entry which shall include all fees. \$100,000 Guaranteed (Includes \$36,250 from Mystic Lake Purse Enhancement Fund) (Includes \$27,500 from the Minnesota Breeders Fund) (Plus \$10,000 from the Minnesota Breeders Fund for horses Sired & Foaled in Minnesota) of which \$60,000 to the owner of the winner. All other purse monies paid corresponding with purse schedule in the Condition Book. Weight: 120 lbs. Maidens allowed 5 lbs. Starters to be named through the entry box by the usual time of closing. The Northern Lights Debutante will be limited to fourteen (14) starters. High weights on the scale will be preferred. Total earnings will be used in determining the order of preference of horses assigned equal weights. Failure to draw into the race will result in a refund of the entry fee. A trophy will be presented to the winning owner. Nominations closed Monday, April 1 with 46. (S)

RUSH HOUR TRAFFIC, bumped, then squeezed between rivals at the start while losing some position to the leaders, was prompted to advance to contention between foes nearing the turn, continued with a steady bid pressing the issue outside the pacesetter into upper stretch, then wrested the advantage in late stages to go clear under firm encouragement. DEFEND THE ROSE was urged to fore from the break outside a rival, went clear while angling to the rail after the opening furlong, set the pace to upper stretch while being roused to resist the winner's challenge but proved no match for that rival late. STYLIN N PROFILIN broke inwards bumping the eventual winner, was urged to contention three deep racing to the turn but lacked the needed final kick while prevailing for a share. RENTAL POOL broke outwards bumping the eventual winner, was righted to track off the second flight, angled out racing into upper stretch but had no rally. HOTASAPISTOL, urged to gain a forward placing while angling to the rail in the opening furlong, tracked the pacesetter inside foes to the turn and soon faded. GREY WAVE broke slowly, shifted out to make brief progress four wide racing into the turn but lacked a closing response.
