## **Footnotes**

COLLUSION ILLUSION chased three wide around the turn, angled in with a furlong to go, rallied up the inside and edged LEXITONIAN on the line. LEXITONIAN off a bit slow to begin, lagged behind early, traveled two wide then came out on the turn, rallied widest in the drive, closed fast and just missed. LAW ABIDIN CITIZEN vied four deep into and around the turn, took a short lead at the quarter pole, dueled three wide into the lane, battled through the stretch and got outfinished by the closing pair. WILDMAN JACK vied five deep into and around the turn, dueled four wide entering the stretch, assumed control at the eighth pole but flattened a bit late and was edged for third. HEARTWOOD well placed behind the battle on the front end, went five wide around the turn and took aim at the top of the lane but flattened out in the final furlong. FASHIONABLY FAST vied three deep and between rivals, led briefly around the turn, outpaced into the stretch and faded. ANYPORTINASTORM vied inside, steadied nearing the guarter pole, angled out in the stretch and weakened. DESERT LAW vied between runners then along the inside into the lane and gave way.
