

SHOW ME THE MINTS was away in good order to set a pressured pace from the inside, opened a clear margin into the lane and drew off with complete authority. HAVEULOSTYOURMIND raced unhurried early, angled out sharply nearing the quarter and finished with good late energy. BRETT tracked the leaders from the inside throughout and failed to gain in the drive. HARBORS RULE lacked early foot, raced five-wide through the turn and finished with some late run. COLEINATOR was off a step slow, raced four-wide through the turn, angled in nearing the three-sixteenths pole and finished evenly. NORTHLAND CABLE lacked early foot, raced four-wide through the turn and was not a factor. REDDY TO STAR broke sharply to press the pace of the winner while racing three-wide and weakened after going a half. RACE OFFICE raced off the pacesetters early, moved four-wide through the turn and weakened. RACE FIVE WAS HAND TIMED.
