BETTOR TRIP NICK broke running and was quickly in front, set the pace from the rail to the stretch, kicked away to mid stretch then was getting a bit weary but held determinedly. DOC TOMMY was outsprinted to the turn, raced three wide to the stretch then closed steadily but too late. FORE LEFT stalked the winner to the turn, followed that one inside to the stretch, got outkicked to mid stretch and finished evenly. BLAISIN' EAMON had no speed, saved ground to the stretch but lacked a closing response. CALL ME PEPPY broke a bit slow, had no speed and was not a threat. NO LONGER SILENT pressed the winner two wide to the stretch then tired.
