FREE INDEED dueled from the inside early, battled up the backstretch, remained engaged through the drive but could not withstand the winner and just lasted for the place. SEA BEE SALUTE allowed to settle early, advanced outside through the second turn, responded when sat down for the drive but just missed the place. CRIMSON ZIP dueled from the outside early, battled up the backstretch, remained engaged entering the drive but had nothing left. VALIANT DEFENDER forced the early pace inside but was empty for the drive. VIOLATOR went evenly. ROSSLARE HARBOUR could only pass tiring rivals. OUTOFMYBIND chased the early pace and tired. FAST VERDICT forced the early pace and faded. SLAM'S MAN was up close early, stopped, was eased and vanned off.
