

TYBALT lacked speed, was wide on the turn, angled to the six path in upper stretch, offered a mild advance to mid stretch and flattened out. WENDELL FONG hugged the inner rail, moved up turning for home and failed to sustain his bid. MOUNT TRAVERS, a forward factor to the stretch, gave way. TRAINFOURTWENTYONE, outrun, raced along the rail on the turn.
