## **Footnotes**

IRISH MIAS saved ground stalking the pace, found room inside his stable mate in mid stretch, gained the lead inside the sixteenth pole and drifted out late. TORRES DEL PAINE showed speed along the rail, was difficult to rate down the backstretch, saved ground the far turn prompting the pace, gained a short lead while drifting out approaching the eighth pole, drifted in a bit near the eighth pole and drifted out late. DOC BOY saved ground around the far turn, eased out entering the stretch, rallied and was steadied in close quarters behind the winner approaching the wire. FIELD PASS stalked the pace, circled the far turn three wide, had aim on the lead in upper stretch, flattened out and was floated out a bit by TORRES DEL PAINE in deep stretch. FAIR HAIRED BOY, checked behind the winner approaching the first turn, steadied along the rail in traffic near the half mile pole and showed some late gain. BENNY HAVENS set a pressured pace in the two path and weakened in the drive. MISCHEVIOUS ALEX, three wide the first turn, failed to be a factor. JACK THE RIPPER (FR) trailed. There was a stewards' inquiry concerning the stretch run but no action was taken. An objection by the rider of DOC BOY against the winner for alleged interference in the stretch drive was not allowed. Objections by the riders of DOC BOY, FIELD PASS and BENNY HAVENS against TORRES DEL PAINE for alleged interference in the stretch drive were not allowed.
