Footnotes

CE CE broke well, settled off the pace well out in the strip, continued to race outside under light restraint in the run up the backstretch, in the four path entering the stretch, set down when straightened for home, closed with good resolve to be up in the final strides. OLLIE'S CANDY broke sharp, narrowly showed the way through the first turn, shook clear onto the backstretch, rated the middle half mile, called on for some run late in the final bend, continued to hold a sizable advantage past the furlong marker, just failed to contain the winner in a solid effort, clearly second best. POINT OF HONOR last away, devoid of speed in trailing for over five furlongs, moved out to be six wide out of the final turn, closest willingly down the middle of the track to garner the show.

STREET BAND unhurried in the early going, continued back early backstretch, began to advance into the far turn, dropped to the fence soon after improved steadily into the lane, flattened out late to be caught for the show. SARACOSA well back off the pace, asked to run late in the final turn, angled five wide into the lane, displayed a moderate amount of late interest to improve while remaining well out in the strip. HOROLOGIST settled off the pace while toward the inside, began to move closer midway on the final turn, blocked behind horses into the lane, continued to lack room until a furlong remained, shift out a bit and finished with late energy. GO GOOGLE YOURSELF raced in mid pack while off the inside, moved a bit closer while four wide and in traffic turning for home, flattened out in the final furlong to lose a couple of positions. LADY APPLE void of speed, in some traffic out of the final turn, improved a bit in the drive while not a major player. AWE EMMA went one paced throughout in lacking a late punch. QUEEN NEKIA broke back and was never a threat. SERENGETI EMPRESS broke with the leaders, pressed the issue through the first turn in the three path, continued to pursue the pace the middle half then gave way in the drive. COME DANCING forwardly placed for six furlongs just off the inside, also had little left for the drive. COLDWATER in mid pack for five furlongs just off the inside, gave way in the second turn. COOKIE DOUGH vied up front early between horses, chased the runner up up the backstretch, stopped in the far turn, finished far back, jogged in.
